#### I. PERSONNEL

- 1. The Superintendent and Elementary School Principal recommend Board approval to hire an Elementary School Physical Education Teacher, at the Master's Step 4 rate of \$56,320, effective for the 2024-2025 school year, pending receipt of required documents.
- 2. The Superintendent and Intermediate School Principal recommend Board approval to hire an Intermediate School Special Education Teacher (life skills/autistic support), at the Masters +30 Step 4 rate of \$54,500, effective for the 2024-2025 school year, pending receipt of required documents.
- 3. The Superintendent and Intermediate School Principal recommend Board approval to hire a Permanent Substitute Intermediate School STEAM Teacher, at the Bachelor's Step 1 rate of \$51,750, prorated, effective for the 2024-2025 school year, pending receipt of required documents.
- 4. The Superintendent and Intermediate School Principal recommend Board approval to hire a Long-Term Substitute Special Education Teacher, at a daily rate of \$160, effective for the 2024-2025 school year, pending receipt of required documents.

- 8. The Superintendent and Administrators recommend for Board approval to create a PBIS Specialist position for Grades 1-5 during lunch and recess at an hourly EPR rate; teachers would elect to forgo their duty free lunch to fill this daily grade level position.
- 9. The Superintendent and Director of Student Services recommend Board approval of a placeholder for the following positions for the 2024-2025 school year, pending receipt of required documents:
  - Paraeducator High School
  - Paraeducator Middle School
- 10. The Superintendent and Food Service Director recommend for Board approval to hire a Food Services Middle School General Worker, Main Station at the probationary rate of \$12.61 per hour; after completion of a successful probationary period, the rate will be \$15.76 per hour, effective for the 2024-2025 school year, pending receipt of required documents.
- 11. The Superintendent and Food Service Director recommend for Board approval to hire a Food Service Substitute at the rate of \$9.25 per hour, effective for the 2024-2025 school year, pending receipt of required documents.
- 12. The Superintendent and Food Service Director recommend for Board approval the resignation of a Cafeteria Worker, effective August 15, 2024.
- 13. The Superintendent and Athletic Director recommend for Board approval a Volunteer Assistant Girls and Boys Cross Country Coach for the 2024-2025 fall season.
- 14. The Superintendent and Director of Student Services recommend for Board approval to an ESL Teacher contract from 50% to 75%, effective for the 2024-2025 school year. This is included in the 2024-2025 budget.
- 15. The Superintendent and High School Principal Natasha Dirda recommend Board approval to increase an Orchestra Teacher contract from 50% to 75%, effective for the 2024-2025 school year. This is included in the 2024-2025 budget.
- 16. The Superintendent and Director of Student Services recommend for Board approval to adjust the position of an ESY Paraeducator to ESY Personal Care Paraeducator, retroactively, at the rate of \$21.96 per hour for the 2023-2024 school year and at the rate TBD per hour for the 2024-2025 school year. This is based on student need.
